Relation to State, Local, and Other Federal Laws. State laws on wages and hours also apply to employment subject to this Act. When both this Act and a state law apply, the law setting the higher standards must be observed. For example, if a state law requires a minimum wage higher than the minimum wage required by the Act, the employer must pay the higher minimum wage.

Any worker whose services are specifically covered by law. An employee may perform services on a temporary or less than full-time basis. The law does not exclude services from employment that are commonly referred to as day labor, part-time help, casual labor, temporary help, probationary, or outside labor.
