Guideline development and use. Discussing prognosis and end-of-life issues has been identified as an important component of care by patients with progressive life-limiting illnesses, and their families.^{1, 2} Being adequately informed is essential for such patients and their caregivers to participate in decisions about their treatment and care, to set goals and priorities, and to prepare for death.

Clinical practice guidelines for communicating prognosis

When faced with difficult end-of life care decisions, families and physicians sort through many issues – legal, ethical, medical and more. These resources can help families sort through their options.

Health Care Proxies and End of Life Care

Abortion is the ending of pregnancy due to removing an embryo or fetus before it can survive outside the uterus. An abortion that occurs spontaneously is also known as a miscarriage. When deliberate steps are taken to end a pregnancy, it is called an induced abortion, or less frequently an "induced miscarriage". The word abortion is often used to mean only induced abortions.
